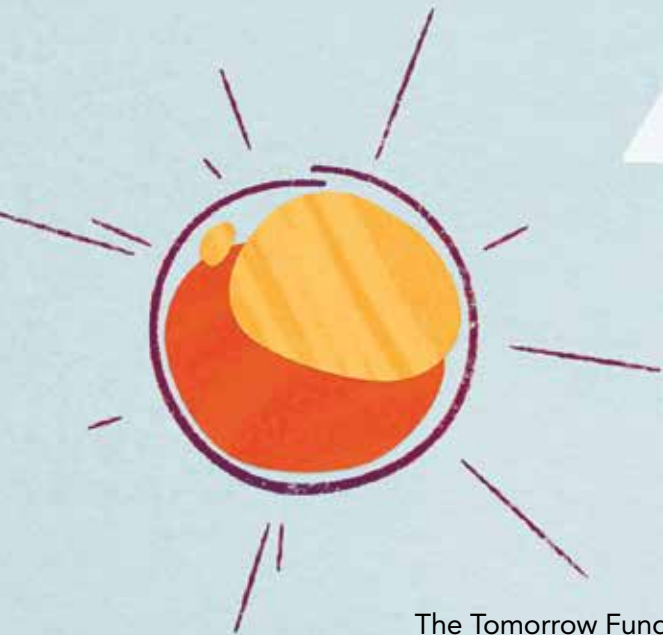

Gifts to the Tomorrow Fund are invested for the long-term; the interest earned pays dividends in the form of community investments that address pressing social issues and support local programs. Annual distributions from the Tomorrow Fund support programs and initiatives that help individuals achieve financial stability, support early childhood development, and connect seniors to their communities. In 2022, the Tomorrow Fund distributed \$3,494,000 to the community.
